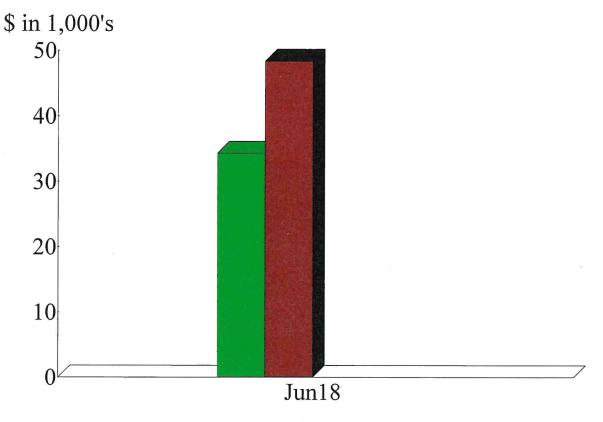

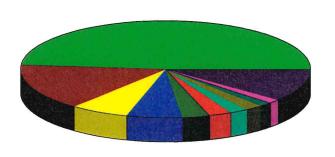

Income and Expense by Month June 2018





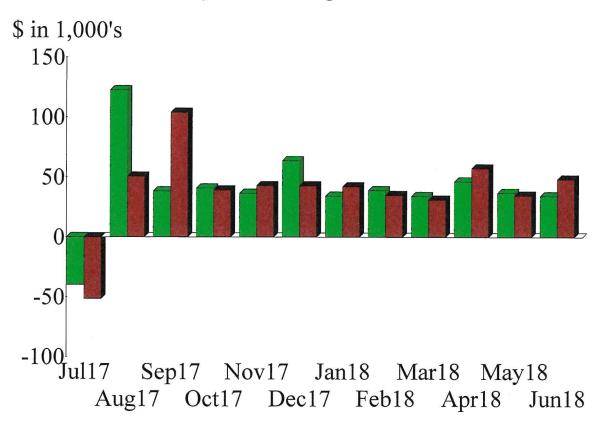

Conflict of Interest Policy

DESIGNATED EMPLOYEES AND REPORTABLE INTERESTS IN INVESTMENTS, BUSINESS POSITIONS, REAL PROPERTY AND INCOME

The Political Reform Act (Government Code §§ 81000, et seq., hereinafter referred to as the Act) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission ("FPPC") has adopted a regulation (2 California Code of Regulations § 18730) which contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearings, it may be amended by the FPPC to conform to amendments in the Act. Therefore, the terms of § 18730 and any amendments to it adopted by the FPPC are hereby incorporated by reference. This regulation and the text here designating officials and employees and establishing disclosure categories shall constitute the conflict of interest code of the District.

Designated positions shall file statements of economic interests with the District. Upon receipt of the statements, the District shall make and retain a copy and forward the original of this statement to the County Clerk of the Board of Supervisors. Statements of Economic Interests are public records available for public inspection.

DESIGNATED POSITIONS: The designated positions listed below are required to file Form 700 Statements of Economic Interests disclosing certain personal financial interests. These positions are required to file the applicable individual schedules to report investments, business positions, sources of income and interests in real property located in the District's jurisdiction. The applicable schedules to be filed for each position are based on the disclosure category assigned to the designated position.

DESIGNATED POSITIONS:

Board Member - Category 1

General Manager - Category 1

Operations Supervisor - Category 1

Consultant - Category 2

DISCLOSURE CATEGORIES:

Disclosure Category 1: Persons in this category shall disclose:

Interests in real property located entirely or partly within District boundaries, or within two miles of District boundaries, or of any land owned or used by the District.

Investments or business positions in or income (including gifts, loans and travel payments) from sources that provide, plan to provide, or have provided in the last two years facilities, goods, software, hardware, or services, including consulting services, to the District, or are engaged in the acquisition of real property within the District.

Disclosure Category 2: Persons in this category shall disclose:

Consultants shall disclose pursuant to the broadest disclosure category in the conflict of interest code subject to the following limitation: The District may determine in writing that a particular consultant is hired to perform a range of duties that is limited in scope and, thus, is not required to comply with the full disclosure requirements described above, but instead must comply with more tailored disclosure requirements specific to that consultant. Such a determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of the disclosure requirements.

LEBEC COUNTY WATER DISTRICT RESERVE FUND POLICY

Adopted July 24, 2018 Resolution No. 2018-724

Purpose

Lebec County Water District recognizes the importance of adopted policies relative to Reserves and Reserve Funds. Written adopted financial policies relative to designated reserves and reserve funds have many benefits and represent a critical element of sound fiscal management. It is the intent of this Reserve Fund Policy to clearly identify both Reserve Fund categories, Reserve Fund purposes, as well as set target levels for reserves that are consistent with the District's mission statement and the philosophy of the District's Board of Directors. This policy establishes the level of reserves necessary for adequately providing for:

- Funding infrastructure replacement.
- Economic uncertainties and other financial hardships.
- Local disasters or catastrophic events.
- Future debt or capital obligations.
- Cash flow requirements.
- Unfunded mandates including costly regulatory requirements.

Policy

Operating Reserves

The minimum amount of operating reserves will equal two months of operating expenses. The maximum amount of operating reserves will equal three months of operating expenses.

Capital Replacement/System Improvement Reserves

Capital Replacement/System Improvement Reserves will be accumulated to fund infrastructure. A key objective for accumulating capital reserves is to minimize external borrowing and interest expense. The minimum amount of Capital Replacement/System Improvement Reserves will equal \$300,000. The Maximum amount of Capital Replacement/System Improvement Reserves will equal \$600,000

Emergency Reserves

The purpose of the Emergency Reserve Funds is to accumulate sufficient financial reserves necessary to insure a timely response by the District to natural disasters and/or other emergencies. This reserve fund will provide for rapid response and continued operation of the District's essential services during periods of natural disasters and/or other emergencies. The minimum amount of Emergency Reserves will equal \$120,000.

Self-Insurance Reserves

The purpose of the Self-Insurance Reserve is to insure payment of outstanding accrued vacation time upon a District employee's separation of service from the District as well as the annual fee for Liability Insurance, Workers Compensation Insurance and Employee Health Insurance. The minimum self-insurance reserve will equal \$45,000. The maximum Self-Insurance Reserves will equal \$90,000.

Equipment Replacement Reserve Fund

The purpose of the Equipment Replacement Reserve Fund is to accumulate sufficient reserves necessary to insure timely replacement and upgrade of the District's vehicles, mobile equipment, and appurtenances thereto. Safe, reliable and up-to-date vehicles and equipment, in good working order, are essential for the provision of public services in a timely and professional manner. Due to the need for depreciation and replacement of vehicles and other mobile equipment it is desirable for the District to set aside funds on an on-going basis for this purpose. The minimum amount of Equipment Replacement Reserves will equal \$60,000. The Maximum amount of Equipment Replacement Reserves will equal \$120,000.

Procedure for Using Reserve Funds

Operating Reserves

Operating Reserves can be used at any time to meet cash flow requirements of District operations. Authority to use the funds will be consistent with the District's Purchasing Policy.

Capital Replacement/System Improvement Reserves

The Board of Directors will authorize use of Capital Replacement/System Improvement Reserves during the budget process. Capital Replacement/System Improvement Reserves are also available for unplanned (unbudgeted) Capital Replacement System Improvement. Authorization for the use of reserves for unplanned Capital Replacement/System Improvement will be consistent with the District's Purchasing Policy.

Emergency Reserves

The Emergency Reserve Fund shall be designated as a restricted reserve fund. The Emergency Reserve Fund shall be expended solely for the purpose of responding to and maintaining District operations during a natural disaster and/or emergency. The District Manager is authorized to approve the expenditure of Emergency Reserve Funds, without prior approval of the Board of Directors, for purposes of restoration and/or maintenance of essential service levels in response to a natural disaster or other emergency. Upon expenditure of any Emergency Reserve Funds, the District Manager shall notify the Board of Directors at the earliest possible opportunity. Expenditures from this designated reserve fund which are subsequently recovered, either

partially or fully, from FEMA, OES, insurance and/or any other sources, said revenue shall be utilized solely for the purpose of refunding the Emergency Reserve Fund.

Self-Insurance Reserves

Operating and self-insurance reserves can be used at any time to meet cash flow requirements of District operations. Authority to use the funds will be consistent with the District's Purchasing Policy.

Equipment Replacement Reserve Fund

The Board of Directors will authorize use of the Equipment Replacement Reserve Fund during the budget process. The Equipment Replacement Reserve Fund is also available for unplanned (unbudgeted) Equipment Replacement. Authorization for the use of reserves for unplanned Equipment Replacement will be consistent with the District's Purchasing Policy

Funds transferred from the Equipment Replacement Reserve Fund shall be expended solely for the purpose of replacement and upgrade of existing District vehicle, mobile equipment and appurtenances thereto.

This policy shall be reviewed on an annual basis for long-term adequacy and use restrictions.

Procedure for Monitoring Reserve Levels

The General Manager shall perform a reserve analysis to be submitted to the Board of Directors upon the occurrence of the following events:

- Board of Directors' deliberation of the annual budget;
- Board of Directors' deliberation of a service charge rate increase;
- Upon renewal or disbursement of the self-insurance excess insurance coverage; or,
- When a major change in conditions threatens the reserve levels established within this policy.

If the analysis indicates projected or actual reserve levels falling 10% below or above the levels outlined in this policy, at least one of the following actions shall be included with the analysis:

- An explanation of why the reserve levels are not at the targeted level, and/or
- An identified course of action to bring reserve levels within the minimum and maximum levels prescribed.
