#### **System Information:**

- 1) All monthly bacteriological sampling returned an absent for coliform bacteria for the month of October 2018.
- 2) Source monitoring is completed for the fourth quarter of 2018. Results of the running average is displayed on page one. The numbers remain relatively the same, for all three sources.
- 3) One water leak was repaired using the assistance of Santana's Pumping. This leak was located at the corner of Landfill Rd and James Ways. Operators were in the process of exercising valves. The top of a 2" gate valve sheared off spewing water about. The Landfill Rd had to be isolated cutting service off to the customers on Landfill Road and James Way. The repair went smoothly and was repaired using a 2" gate valve and miscellaneous 2" galvanized piping and joints. "Please see attached photos"
- 4) Water Resource Control Board District 19 has issued this statement regarding Lead exceedance,

The State Water Resources Control Board, Division of Drinking Water (hereinafter "State Water Board") has received the lead and copper monitoring results for 2018 for Lebec County Water District (hereinafter "District"), public water system. The data shows that the lead 90<sup>th</sup> percentile was 0.021 mg/L which exceeds the 0.015 mg/L lead action level. A summary of the Lead monitoring results on file with the State Water Baord can be found in **Appendix 3**. Since the lead action level was exceeded, the District is required to conduct standard tap sampling, source water monitoring, water quality parameter (hereinafter "WQP") monitoring, a corrosion control study (hereinafter "CCS"), lead service line replacement, and a lead public education program.

For information please feel free to read the actual Lead Action Level Exceedance And Public Education Program For Systems Serving A Population Of 50,000 Persons Or Less For Lebec County Water Disrtict.

- 5) I like to ask the board to table The Topics of Isolation and Telemetry of the Lebec well till the next meeting. I need more time to put together a summary of isolation and pricing for the telemetry setup.
- 6) The Dodge has had the transmission serviced at its scheduled interval of right around 60,000 miles. Chevy Truck has had its routine oil change and maintenance done also.
- 7) The C-Train has been reorganized and a additional shelve has been added. The extra room has made this area very functional now. "Please See Attached Photos.

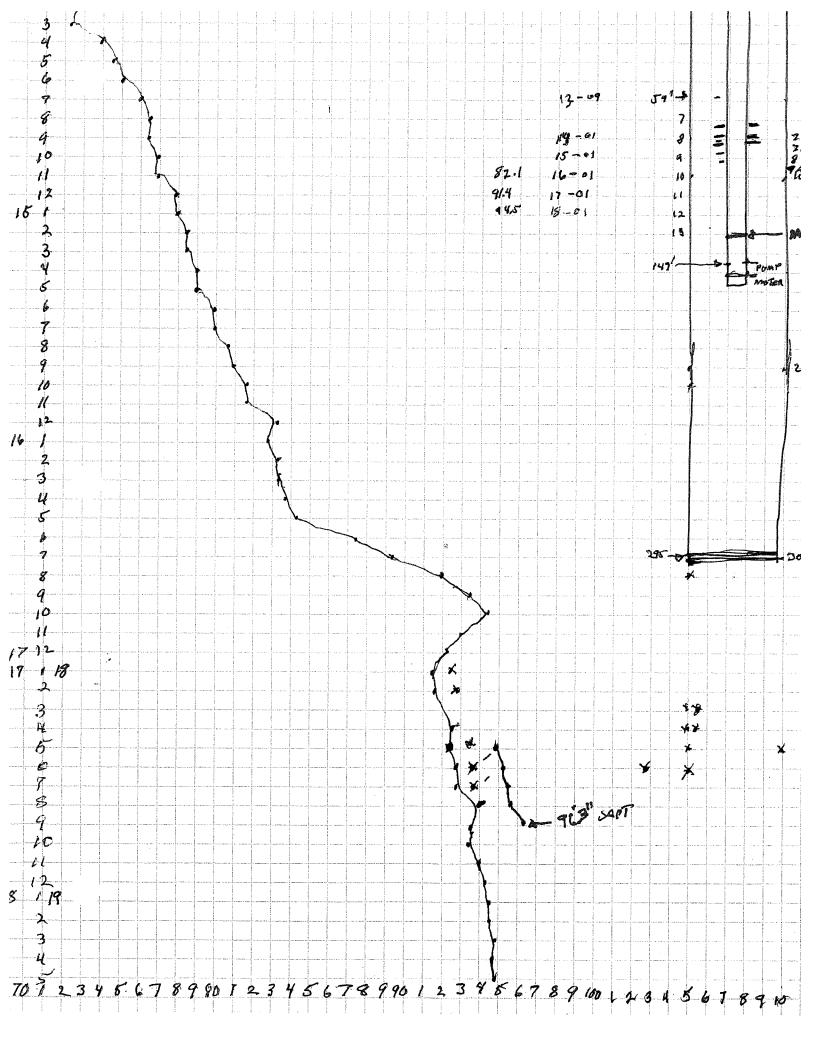
